



Last week, a number of small- and medium-sized businesses were hit by a major cyberattack, causing other companies around the world to fear the same. The Biden administration said it's working to prevent further cyberattacks.

Between 800 and 1,500 businesses around the world were compromised or affected by a cyberattack on Friday that security experts said could be the largest attack in history using ransomware, in which hackers shut down systems until a ransom is paid.

The world's largest meat processing company has paid the equivalent of \$11m (£7.8m) in ransom to put an end to a major cyber-attack.

Computer networks at JBS were hacked last week, temporarily shutting down some operations in Australia, Canada and the US.

The payment was reportedly made using Bitcoin after plants had come back online.

A Warning for Law Firms

The first of the quarterly 2021 surveys appeared in April, and the news isn't good for small and midsized law firms. Note these ominous words from Coveware, a highly regarded aggregator of global ransomware and cyber extortion data, which published the Coveware Quarterly Ransomware Report (Q1 2021):

"The most notable change in industries impacted by ransomware attacks in Q1 was the professional services industry, specifically law firms. Small and medium sized law firms continue to succumb to encryption ransomware and data exfiltration extortion attacks. Unfortunately, the economics of many small professional service firms do not encourage or enable adequate cyber security."






Protect Against Phishing

- If you get a link from a service you use, don't click the link. Type the address into the browser and login in manually.
- Use software with strong spam filters like Gmail or Office 365.
- Consider using SaneBox as well.
- Use two-factor authentication.
- If you think you fell for a phishing attack, reset your password for that service & notify your system administrator.








Phishing + Social Engineering = Spear Fishing

Spear fishing are targeted attacks on individuals.

A spear fishing email is more convincing and seems like it was meant for you.

Instead of a link, the email may have a malicious attachment.







Protect Against Spear Phishing

- Beware any emails that aren't formatted the same as an email typical from the sender.
- Make sure that the email address and name match the senders.
- Use two-factor authentication.
- Make sure your email program has virus scanning software installed and up to date.










Two-Factor Authentication

CRITICAL: Keep your software up-to-date

- Apple and Microsoft send out security updates FOR A REASON.
- They patch unknown and known vulnerabilities.
- Most ransomware attacks exploit systems that haven't been updated.






Most attacks are entirely preventable

"This attack demonstrates the degree to which cybersecurity has become a shared responsibility between tech companies and customers. The fact that so many computers remained vulnerable two months after the release of a **patch** illustrates this aspect. As cybercriminals become more sophisticated, there is simply no way for customers to protect themselves against threats unless they update their systems." - Microsoft, 2017






Password Policy is Critical


1. Plaintiff, Alexander Jung, is a Korean-American male born February 21 1965, who served in the United States Army from October 29, 1986 until October 29, 1989




